



Instructions to LCP & Applicant For Missouri State Chapter's "ExCEL Award"

The ExCEL Award is awarded to REALTOR® or REALTOR®-Associate local chapter member holding membership in WCR no longer than 3 years. It is awarded annually by the Missouri Chapter of Woman's Council of REALTORS® at the annual Installation and Awards Banquet. This Award is presented to the recipient who demonstrates Excellence in Cooperation, Education and Leadership.

The award recipient will receive \$100 toward a tuition scholarship for one of the following courses: GRI, CRS, CRB or LTG, or other NAR accredited courses. Should the recipient prefer, the award can be used for the registration fee and hotel room (not to exceed \$100.00) for the Missouri Association of REALTORS® State Convention. The award must be used within the next 12-month period.

The Local Chapter President and the nominee are to complete the attached form, obtain the letters requested in word documents or by e-mail. E-mail all information together and *return to the Vice-President of the State Chapter by August 15th*.

2006 AWARD:

1. Applicant must have joined WCR after July 1, 2003.
2. Points for categories C, D, and E must be earned between July 1, 2003 and June 30, 2006
3. LCP's will get form from Chairman in Spring.
4. Applicant may only receive state ExCel award once
5. Chairman must receive local Chapter nominee's application by August 15, 2006.
6. Committee meets Fall 2006 to select the recipient at convention.
